Annual Membership Meeting Event



On June 4th, 2010 your Chapter Board of Directors hosted our Annual Membership Meeting. Over eighty attendees enjoyed presentations by local business leaders and saw a few outstanding individuals honored with NDIA awards. The event was held in the lovely conference rooms of the ACIN Technology Center in Camden, NJ, overlooking the Delaware River with the Philadelphia skyline in the background. ACIN is America's first small business accelerator dedicated to severing the US Department and Department of Homeland Security. Established in 2001, the mission of ACIN is to identify small business and technologies that make information delivery faster, more secure and more flexible. Tony DeMarco, Chapter President, opened the event by welcoming the guests and describing the program focusing on Defense Acquisition Reform and Weapon Systems Affordability. Next, Ed Celliano, ACIN General Manager, presented the ACIN business accelerator initiatives and described the technologies pioneered by ACIN member companies. The presentations that followed are summarized below

Tony Corwin, Blank Rome Impact of the 2009 Weapon Systems Reform Act (WSARA) to Defense Contractors

Signed into law just over one year ago, WSARA made significant changes to the acquisition and cost control processes for Major Defense Acquisition Programs, strengthening the regulations against cost over-runs and providing more structure within the Pentagon to manage these major programs. General Corwin look4r at both the legislative language as well as its implementation within DoD to determine whether WSARA has met its expectations over the past year.

Carmen Valentino, Vice President, Future Surface Combatants, Lockheed Martin Affordability Engineering at Lockheed Martin

Carmen Valentino presented an approach to ensuring engineering affordability. Lockheed Martin is able to deliver proven technologies to the warfighter that align to the government's affordability goals by promoting open-standards

and strategic supplier partnerships.

Karen Wilson, Director, Acquisition and Industrial Base Policy Government Operation, Boeing Acquisition Reform and Affordability at Boeing

Karen Wilson discussed the complexities in Defense acquisition process, and the integrated systems approach that Boeing has developed to deal with these challenges. She presented examples of the six sigma process that was successfully employed. Karen concluded with suggestions for how to thrive in this new environment of constant change and complexity

Congressman Rob Andrews, NJ 1st District and Panel Chairman—Keynote Address

Each guest speaker presented important facts about WSARA, how their companies are addressing the Defense Departments affordability concerns, and how each one of us will be affected by acquisition reform initiatives. The keynote address by Congressman Andrews was especially captivating, as he related stories of how local technology was at work in our battles overseas, and of his efforts in Washington to help the warfighter.

We wrapped up the event by presenting three awards to outstanding individuals with great accomplishment in the Chapter. The awards are summarized below:

Henry S. Rothrock Distinguished Service Award

This award is in memory of Henry S. Rothrock, a long-time member and emeritus member of the board of directors of the Delaware Valley Chapter and its predecessor organizations. The award is presented periodically to a senior individual who has demonstrated strong support for defense and/or industrial preparedness. This award was presented to John I. Ykema, P.E. Mr. Ykema is Vice President and Chief Technical Officer of L-3 SPD Electrical Systems. He is responsible for the technical review and oversight of development programs and for the evaluation and marketing of SPD's technical program capabilities. He is responsible for the evaluation of technology trends in the industry and their impact on SPD's strategic initiatives.

C. Jared Ingersol Liberty Bell Patriots Award

This award is in memory of C. Jared Ingersol, a Philadelphia industrialist and one of the founders of the Delaware Valley Chapter and its predecessor organizations. The award is presented periodically to a relatively junior individual who has demonstrated strong support for defense and/or industrial preparedness. This award was presented to Tyler Moler. Tyson works for a small business, GoAhead® Software, and was instrumental in promoting open-standards across the defense industry. His efforts have helped bring proven technologies to the warfighter, while enhancing af-

fordability and competition. Tyson has briefed multiple levels of every service branch on affordability and open standards, including RDML Benedict. He has helped both PEO-C4I and PEO-IWS develop cost savings approaches in their acquisition plans, held training sessions for Navy Lab personnel, and hosted multiple service sessions to help promote open requirements across the defense industry. Tyson has also supported his community through volunteer work in both Big Brother/Big Sister and Youth Soccer.

The John C. Jones Award

Finally, the National Defense Industrial Association (NDIA), Delaware Valley Chapter, recognized Congressman Rob Andrews for his outstanding support of the defense industry with our highest honor, the Jones Award. The award is named after John C. Jones, the first Chief of the U.S. Army Philadelphia Ordnance District established in 1918. Mr. Jones accomplished the herculean task allotted to the district which was a direct a blow to the Prussian Militaristic World Control hopes of the time. The Jones Award is presented periodically to an individual who is prominent at a regional, national, or international level for his/her support for a strong defense posture and robust industrial base capabilities.

Congressman Andrews was singled out for his work on the House Armed Services Committee, his support for our troops, his sponsorship of the ACIN defense focused business incubator, and his support of the local defense industrial base. The approval vote by the board of directors was unanimous.

Previous Jones Award recipients included Cong. Curt Weldon, VADM Joseph Metcalf, LTG Robert Forman, USA, and General Curtis LeMay, USAF.
